### 1. School Board of Palm Beach County

In June 2007, Turner entered into an agreement to resolve a dispute with the School Board of Palm Beach County arising out of Contracts with the School Board to construct three schools. During the final settlement negotiations, the School Board requested that Turner voluntarily agree to refrain from bidding on any of its projects for a period of three years. This is the School Board's standard practice when it negotiates settlements. In light of the fact that Turner had already made an independent decision not to bid on any further work for the School Board, and that it was very satisfied with the financial terms of the settlement, it readily agreed, provided that the agreement also state that there was no admission of liability, express or implied, by virtue of the terms of the settlement agreement. In addition, Turner insisted that the agreement explicitly state that Turner's agreement to refrain from bidding shall not be used as support for a decision as to responsiveness, responsibility or otherwise on any proposals that Turner chooses to submit after the expiration of three years. Turner was pleased with the settlement, which provided that Turner would be paid its full contract balance, plus certain extras that had been claimed by Turner.

The requirement that Turner refrain from bidding expired in June 2010, and Turner is again able to bid.

### 2. SCA PS 292

On June 8, 2010, Turner was notified that it was the apparent low bidder on the New York City School Construction Authority's ("SCA") PS 292 project in the Bronx. Unfortunately, Turner was also notified that its bid was being rejected by the SCA as "non-responsive" because the Plumbing and Gas Fitting Wicks subcontractor that Turner included in its bid package had let its qualification lapse, and so was not prequalified at the time of bid opening, as is required by the SCA. Turner was unaware that this had occurred.

### 3. Polk County Board Of Education

On or about November 17, 2008, Turner received a letter from the School Board of Polk County, Florida, stating that, as of November 12, 2008, Turner was in default of a contract that it had entered into with the Board. The School Board did not terminate the contract and Turner denied that it was in default and completed its work on the project. In June 2010, the issues between the parties were fully and finally resolved at a meeting between Turner and School Board Officials, at which the School Board removed the default and declared its satisfaction with Turner's performance.

### 4. Anaheim Union School District

On or about March 2, 2002, Turner Construction Company ("Turner") entered into a contract with the Anaheim Union School District in Anaheim, California (the "District") to provide construction management services in connection with the construction and/or modernization of several schools in the District. Over the next several years, the various projects suffered delays and cost overruns due to the District's actions and inactions and other circumstances beyond Turner's control. On November 6, 2006,

the District terminated the contract for allegedly unsatisfactory performance. Turner filed suit challenging the termination as being factually and legally improper and in violation of the terms of the contract. The parties recently agreed to settle the matter for almost the entire contract value, and the termination was converted to a termination for convenience by the District.

5. Masonic Care Community

In 2002, Turner entered into a contract with the Masonic Care Community to construct additions and renovations to a nursing home. When the project was approximately 92% complete, the Owner terminated Turner's contract. Turner believed that the termination was wrongful and constituted a breach of contract by the Owner. Turner and the Owner subsequently negotiated a settlement, and the termination was converted into one for convenience.

1. United States Environmental Protection Agency

By letter dated May 30, 2008, Turner was advised by Region III (PA, DE, DC, MD, WVA, and VA) of the United States Environmental Protection Agency ("EPA") that an inspection in September 2006 of a completed project managed by Turner in Warrenton, Virginia revealed that a permit and a pollution prevention plan were not available at the site as required under EPA regulations. The EPA made various requests for information from Turner in connection with its review arising out of the unavailability of the permit and the plan, including in relation to Turner's self-inspection and erosion and sediment control practices. Turner cooperated fully with the EPA's review and complied with the EPA's requests for information. Turner notes that it possessed the appropriate permit and plan at the time of the inspection and that the failure to display them to the EPA's inspectors in the September 2006 visit was merely an inadvertent oversight.

On September 21, 2010, Turner received a "Show Cause" letter from the EPA related to the above. That letter alleges violations relating only to the six sites of Turner's subsidiary, and not Turner. Also on September 21, 2010, Turner also received a second request for information from the EPA that is almost identical to one that it received in May 2008. The only difference is that the 2008 RFI was limited to federal projects in Region III, whereas the 2010 RFI requests information on all projects in Region III (where the land disturbance was more than 1 acre). Turner is in contact with attorneys from the EPA in order to define the scope of the RFI while at the same time gathering information to comply.

2. NYC Department of Environmental Conservation Consent Order

In July 2007, the New York City Department of Corrections (the "NYCDOC") and Turner entered into a Consent Order related to a civil violation of a permit issued by the New York City Department of Environmental Conservation (the "DEC"). The NYCDOC owned a property in the Bronx, and contracted with Turner to provide certain construction management services on the property. The NYCDOC also hired a consultant, Malcolm G. McLaren, P.C., who secured a DEC permit for work in tidal

wetlands near the property. During the course of the project, a "fillet of riprap [was placed] across the seaward face of the vertical retaining wall below the mean high water line", which was an unknowing violation of the DEC permit. While Turner maintained that it had done nothing wrong, in the interest of settling the dispute, the NYCDOC and Turner agreed in the Consent Order: to joint and several liability for the violation; to pay an \$8000.00 civil penalty; to immediately rectify the situation; and to apply for any and all appropriate permits from the DEC for the duration of the project. Turner complied with the terms of the Consent Order and is not aware of any further issues related to it.
