Explain:

On March 16, 2010, the City of Chicago sent a Notice of Proposed Debarment to the Disclosing Party and all the persons identified in Section II.B.1 of the EDS, to which their attorneys have responded, contesting the Notice. No action has been taken on the Notice. Neither the Disclosing Party nor those persons "are presently debarred, suspended, ... declared ineligible or voluntarily excluded from any transactions by any federal, state or local unit of government."
