ATS is not able to certify to Question B.3(d) and provides the following information: 1. In November of 2012, ATS received a notice from the City of Sarasota, Florida, notifying ATS that it has terminated its contract with ATS for the design of a sewer lift station for default. ATS disagrees with the termination. The City of Sarasota ultimately filed suit. ATS is vigorously defending the City's claims and the matter remains pending. 2. In August 2016, ATS received a

letter from the Redevelopment Authority for the City of Milwaukee asserting that the Authority considered its contract with ATS terminated for cause. The City of Milwaukee and ATS had previously discussed the termination of the contract for convenience; however, upon receipt ATS noticed the letter stated the contract was being terminated for cause, not convenience. ATS and the City of Milwaukee are working to resolve this matter and ATS will provide an update once resolved.
