Response:

1. In May 2012, ATS received a letter of termination from its client Covidien, Inc., relating to a remediation project being performed on a Time & Materials basis. At the time this letter was received, ATS was awaiting authorization to continue site activities as the project budget had been exhausted. Covidien refused to issue additional authorizations and refused to make payment on overdue amounts within the prior Covidien-issued authorization. ATS was subsequently forced to file a claim in the Massachusetts state court. Covidien had the matter removed to Federal Court where the claims were consolidated. ATS disputed the validity of the termination. This matter has been settled with payment to AECOM.
2. In March of 2016, ATS received a Notice of Termination for Cause from Atlantic City Electric, a PHI Company, on a Substation Project. AECOM disagrees with the purported basis for the notice and is contesting this notice.
3. In November of 2012 AECOM Technical Services, Inc. ("ATS") received a notice from the City of Sarasota, Florida, notifying ATS that it has terminated its contract with ATS for the design of a sewer lift station for default. ATS disagrees with the termination. The City of Sarasota ultimately filed suit. ATS is vigorously defending the City's claims and the matter remains pending.
