C. Responses to Section V.B Question 2:

With approximately 700 full-time employees and operations in the City of Chicago in over 15 locations, the Disclosing Entity from time to time may inadvertently become delinquent in nonmaterial fines, fees and taxes, but it is Disclosing Party's policy to pay such amounts in accordance with law and to diligently investigate rectify any possible failure to pay and at all times comply in good faith with all applicable legal requirements.

D. Responses to Section V.B, Questions 3, 5, 6, 8:

The Disclosing Party makes the certifications set forth in questions 3, 5, 6 and 8 of Section V.B to the best of its knowledge after reasonable inquiry.

Further, to the best of its knowledge and belief, the Disclosing Party certifies that each of the persons identified in Section II.B.1 of this EDS is able to certify to the

statements set forth in questions 3, 5, 6 and 8 of Section V.B of the EDS, subject to the following qualifications: the persons identified in Section II.B.1 of this EDS as members of the Disclosing Party's Board of Managers are involved in a wide variety of business, charitable, social and other activities and transactions independent of their activities on behalf of the Disclosing Party. With such a large business presence and a wide variety of activities subject to complex and extensive regulatory frameworks at the local, state, and federal levels, allegations or findings of civil or criminal liability, as well as the termination of one or more transactions for various reasons, may have arisen and pertain to or be the subject of matters covered in these certifications. Given that the Disclosing Party has approximately 700 full-time employees and approximately 43 members of the Board of Managers, it cannot certify further. To the extent that such matters come to the attention of the Disclosing Party, however, it is Disclosing Party's policy to diligently investigate any such allegations, promptly resolve any allegations or findings, and at all times comply in good faith with all applicable legal requirements.

As for any Contractor, Affiliated Entity of such Contractors or employees or agents of either (collectively, "Unrelated Entities"), however, the Disclosing Party certifies that it has not hired with respect to the Matter and will not knowingly hire, without disclosure to the City of Chicago, any Unrelated Entities who are unable to certify to such statements.

E. Response to Section V-B-11, 12:

To the best of Disclosing Party's knowledge after reasonable inquiry, none of the persons identified in Section II.B.1 of this EDS were employees, or elected or appointed officials of the City of Chicago during the period of September 1, 2017 through September 4, 2018, with the following exception:

Sharon Fairley, an unpaid volunteer serving as Vice Chair of the Disclosing Party's Board of Managers and an unpaid member of the Disclosing Party's Board of Trustees, was a City of Chicago employee (Chief Administrator, Civilian Office of Police Accountability) until October 2017. The Disclosing Party may have provided Ms. Fairley, along with all other attending board members and solely in her capacity as a volunteer board member, with incidental and occasional food and beverages during scheduled board meetings.

The Disclosing Party has approximately 700 full-time employees and working at multiple facilities in the City of Chicago and is unaware of any particular employee of the Disclosing Party having been a City of Chicago employee or elected or appointed official during the time period previously described. Please note that for its new hires added during such time period, the Disclosing Party did not collect data on immediately preceding employment by the City of Chicago or status of a new hire as an elected or appointed official of the City of Chicago.
