From time to time and in the ordinary course of its business, the Company is subject to various claims, disputes, terminations, arbitrations, and other legal proceedings. It is the Company's practice to vigorously defend itself in such actions, many of which are generally subject to insurance and none of which are expected to have a materially adverse effect on the Company's consolidated financial statements. After diligent search of relevant records, none of any such litigation will impair the Company's ability to perform its Services for the City.

#### Section V.D.1:

We have no knowledge of any financial interest of an officer or employee of the City in the matter. There is no financial interest that would flow from Jacobs to an official or employee of the City in relationship to a Matter. However, because Jacobs is publicly traded it is possible that any officer or employee may own stock in the Company.
