# Reliability Declaration of Siemens Aktiengesellschaft


Siemens Aktiengesellschaft (*Siemens AG*) is a reliable bidder. Siemens AG has taken a multitude of measures to ensure its reliability in terms of public procurement law and to prevent illicit activities from occurring. These measures particularly include the implementation and continuous improvement of a world-wide Compliance System.

In addition, various administrative and judicial decisions prove Siemens AG's reliability. It is especially worth mentioning that the Federal Ministry of Transport, Building and Urban Affairs, the Bavarian Ministry of Economy, Infrastructure, Transportation and Technology as well as the Higher Financial Authority (*Oberfinanzdirektion*) of Frankfurt am Main, Germany, have explicitly confirmed Siemens AG's reliability in terms of public procurement law due to the organisational and personnel measures the company has implemented. This has since been confirmed by decisions of the procurement review chamber of the German State of Brandenburg and the U.S. Defense Logistics Agency. Furthermore, contracting authorities worldwide have shown that they consider Siemens AG to be a reliable and responsible contractor by consistently awarding numerous large project contracts to the company.

# I. The Compliance System of Siemens AG

In 2007 and 2008 Siemens AG established a comprehensive Compliance System which since then has been implemented all over the world and is subject to continuous improvement.

This Compliance System consists of concrete technical, organisational and personnel measures that are appropriate to prevent criminal offences or misconduct and is divided into three action levels: Prevent, Detect and Respond. These action levels encompass a comprehensive system of activities which are designed to ensure that all of Siemens AG's businesses are completely in accordance with all applicable laws and regulations, as well as with its own internal principles and rules.

Comprehensive core element of the Compliance System is the full responsibility of all managers for compliance. All of Siemens AG's employees are obliged to implement the compliance directives. The Business Conduct Guidelines as centerpiece of the internal regulations are binding for all employees worldwide and for all members of the Managing Board. Besides requiring all managers and employees to observe the law, the Business Conduct Guidelines also stipulate precise guidelines for, inter alia, the observance of competition law and anti-corruption law, the correct handling of donations, the avoidance of conflicts of interest in the exercise of job functions, the observance of the prohibition of insider trading and the protection of company assets.

Siemens has retained the law firm Gibson, Dunn & Crutcher LLP ("Gibson Dunn") to conduct an independent review and assessment of the implementation and operative effectiveness of Siemens' anti-corruption policies, procedures, and internal controls based on a risked-based selected number of projects, Divisions and countries. The report concludes with the statement that, based on its review, Gibson Dunn has found that the Siemens Compliance System is adequately designed and implemented to prevent, detect and respond to violations within Siemens of the Foreign Corrupt Practices Act and other applicable anti-corruption laws. It was further found that the Siemens Compliance System meets the requirements of (draft versions of) international Compliance Standards (ISO 19600, ISO/CD 37001.2). Further, based on certain tests of the Siemens Compliance System conducted by Gibson Dunn for the period of October 1, 2014 and March 30, 2015, Gibson Dunn has found that the Siemens Compliance System is effective in its implementation.

comprehensively obliges every acknowledged Siemens' supplier and third party intermediary.

Besides, Siemens facilitates and admits explicitly to the The Ten Principles of the United Nations Global Compact, regarding fundamental responsibilities in the areas of human rights, labour, environment and anti-corruption. The Ten Principles of the United Nations Global Compact are based on the Universal Declaration of Human Rights, the International Labour Organization's Declaration on Fundamental Principles and Rights at Work, the Rio Declaration on Environment and Development and the United Nations Convention Against Corruption. These first principles are also reflected in our Siemens Business Conduct Guidelines. Moreover, in an international framework agreement with employee representatives and the IG Metall, Siemens once more admitted to essential employee rights as equality of opportunity and freedom of tariffs/association.

# II. Completed and ongoing proceedings

Taking into account the important role of judicial decisions and proceedings concerning the reliability of a bidder in public procurement procedures, we wish to inform you in particular of proceedings against Siemens AG or former employees which are on-going or have been resolved within the past years.

# 1. Completed proceedings

# a) Inter-American Development Bank (IADB)

The IADB conducted administrative proceedings in two Latin-American countries against, among others, Siemens alleging misconduct in connection with public invitations to tender in calendar year 2003. In April 2014, a settlement was reached with the IADB which involves a payment of a single digit million € amount and a voluntary restraint from IADB-financed projects for three years by two Latin-American businesses, one of which is no longer owned by Siemens.

# b) European Commission and other antitrust authorities relating to gas-insulated switchgear (GIS) anti-trust violations between 1988 and 2004

In 2007, the European Commission imposed fines on twelve GIS producers, including Siemens AG, for various anti-trust violations in the European GIS market between 1988 and 2004. The decision became final and binding by a judgment of the European Court of Justice dated 19 December 2013. In February 2017, Siemens AG entered into a settlement agreement with the Brazilian antitrust authority CADE relating to the above mentioned alleged antitrust violations in the Brazilian GIS market for an amount in the low single-digit euro million range. Siemens fully cooperated with CADE. Further related national anti-trust proceedings are partly still ongoing.

# c) Israeli Exchange Supervisory Authority (ISA)

On 2 May 2016, the Israeli District Attorney (DA) filed criminal charges versus Siemens Israel Ltd. related to potentially illegal payments that were allegedly paid to Israeli Electric Company-representatives in the early 2000's. Siemens fully cooperated with the Israeli authorities. Siemens AG was not charged as it was possible to conclude a settlement agreement with the DA.

# d) Belgian Competition Authority (BCA)

On 2 May 2017, the BCA imposed a fine on several companies for a cartel concerning a public framework contract for specific rail electrification equipment with the Belgian public railway infrastructure company. The cartel was entered into by several Belgian companies, including Siemens NV, the subsidiary of Siemens AG in Belgium. A fine of less than 1 million Euro was paid by Siemens NV to settle the matter, an amount corresponding to less than 0.2% of the current total turnover of Siemens NV in Belgium. The amount and decision had been previously agreed with the BCA following a negotiated procedure. The decision is final and binding. Only one single employee of Siemens NV was involved in the cartel; his employment relationship was terminated in 2014.

Siemens AG itself was not involved in any wrongdoing but is only included into the settlement/decision as the applicable Belgian competition law holds the parent company liable for the infringement of its subsidiary. No employee of Siemens AG participated in any misconduct. This is also recognized in the decision of the BCA. Siemens NV and Siemens AG actively cooperated with the BCA's investigation, which is reflected in the 50% reduction of the fine and expressly mentioned in the wording of the accompanying press release.

In addition to terminating the employement of the individual involved and the collaboration with the BCA, Siemens NV and Siemens AG have taken additional specific measures to prevent further infringements or misconduct. Such measures included strong statements from the management, that both Siemens NV and Siemens AG pursue a policy of zero tolerance regarding any practices infringing competition law, as well as additionalantitrust trainings. Neither Siemens NV nor Siemens AG have been excluded from public tenders in Belgium.

# e) Hellenic Competition Commission (HCC)

On 3 August 2017, the Hellenic Competition Commission (HCC) served a decision to Siemens AG and Siemens AE, Greece, about violations of Greek and European competition law. The decision, which was made on the basis of a newly implemented settlement procedure in Greece, refers to an isolated incident which occurred during a very short period of time in the early 2000's in the public works sector in Greece. The HCC chose to settle the case with Siemens AG and Siemens AE without imposing a fine. In addition, the settlement decision of the HCC did not find that the conduct of Siemens AG and Siemens AE, had any effect on the market or caused any damage. Siemens cooperated extensively with the HCC since the start of the proceedings in 2016.

# 2. Ongoing proceedings

Public prosecutors and other government authorities in a few jurisdictions around the world are still conducting investigations against Siemens AG and current and former employees. Furthermore, as a company in the field of plant engineering and construction, Siemens AG is exposed to claims of compensation and legal disputes regarding the completion of contracts. Nevertheless, neither of these proceedings influences Siemens' suitability as a bidder in public award procedures, respectively is of such extend, that it exceeds the normal dimension and should be reported in this context. Siemens AG takes all these allegations, investigations and proceedings very seriously and regularly reports on important proceedings in its annual report as well as in the Half-year Financial Report. These reports can be found on the company's homepage<sup>1</sup>. You can find the proceedings in the annual report under section "Legal proceedings" (p. 86 et seq.) and in the Half-year Financial Report under section "Legal proceedings" (p. 13).
