That agreement has concluded. F.H. Paschen has also, by mutual agreement, and with no admission of any liability or wrongdoing, engaged an independent monitor in connection with two MWRD projects dating back to 2010. F.H. Paschen had no restrictions on bidding or contracting with either agency.
