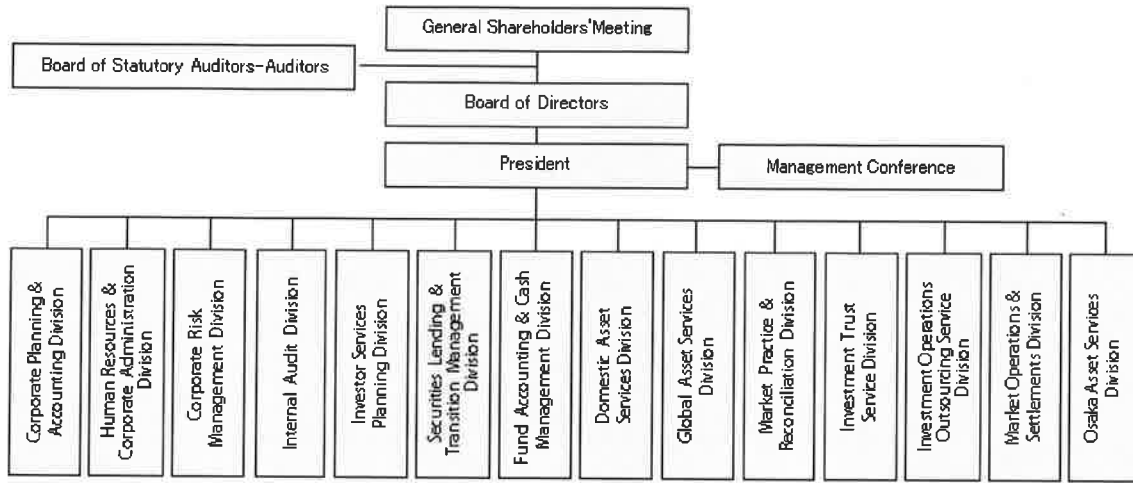

DECLARATION

I, Alexander C. Riemer, hereby declare as follows:

1. I am over eighteen years of age and am competent to testify to the matters in this declaration.
2. I currently serve as Chief Financial Officer of Moore Landscapes, LLC, a position I have held for the past 3 years.
