Farley Building

This involved a disagreement as to Schindler's performance under the subject contract. At the time, the location was in the midst of a building remodel, which had an adverse effect on elevator performance. OGS claimed excessive downtime for elevators. Schindler disputed this. Schindler provided various proposals to upgrade the aged equipment and provided documentation to refute the claim of excessive downtime. In addition, Schindler pursued claims to recover payments that were due under the contract. Schindler eventually filed a Notice of Claim. Numerous discussions occurred between counsel for the parties. Schindler has not pursued its claim further.

Manhattan Psychiatric Center

Schindler had a maintenance contract with Manhattan Psychiatric Center to perform maintenance for nine elevators. Schindler met several times with Manhattan Psychiatric Center to try to resolve certain alleged deficiencies, including callback response times. The parties were unable to resolve their dispute, and Manhattan Psychiatric Center cancelled the contract with Schindler on March 26, 2015. Manhattan Psychiatric Center is located on Ward's Island and Schindler originally serviced this from its Manhattan location. In order to address response times, Schindler reassigned this contract to its Westchester office, which had easier access to the island. Unfortunately, Schindler and Manhattan Psychiatric Center could not come to a resolution.

<u>312 North Spring Street, in Los Angeles, California, 1340 Sixth Street in Los Angeles, California</u> and 125 South Grand Avenue in Pasadena

This is a GSA contract for a United States District Courthouse in California. Schindler maintained this equipment for more than a decade prior to the cancellation by the customer. The units in this courthouse were more than 50 years old. There were issues primarily involving ornate cab and elevator lighting. Schindler expressed its concern that the wiring for these fixtures were a safety hazard and submitted modernization proposals for all of the units. GSA eventually cancelled the contract effective July 31, 2014_citing primarily the lighting issue. The units were subsequently put out for a modernization bid as previously suggested by Schindler. Schindler contends that the termination was not justified given the age and condition of the equipment.
