through a Generational Skipping trust that he controlled. Both Warren's and the Generational Skipping Trusts shares are part of Warren Hill's estate planning process. These shares, previously controlled by Warren, are in the process of being transferred to Warren's five children, one of whom (James B. Hill) is currently President of Hill Mechanical Corp. Barring any unexpected delay, the transfer is expected to be completed by the end of the 2022 calendar year.
