Ltd. holds 11.97% of the shares of NTT DATA Corporation in a trust account where the Bank is a trustee for the benefit of its customers. Japanese authorities do not regard banks holding shares in a trust account as an actual shareholder. Under Japanese law, NTT DATA Corporation is required to disclose to the Japan Ministry of Finance any shareholder owning more than 5% of the company's shares in a large shareholders' report. This year, NTT DATA Corporation did not file information for The Master Trust Bank of Japan, as it is a trustee for the benefit of its customers, nor did NTT DATA Corporation file the information for any other shareholder.
