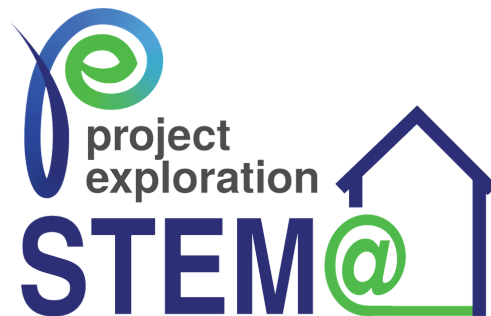
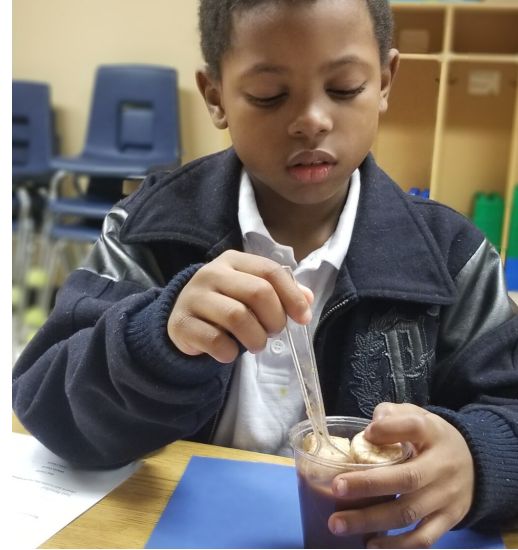
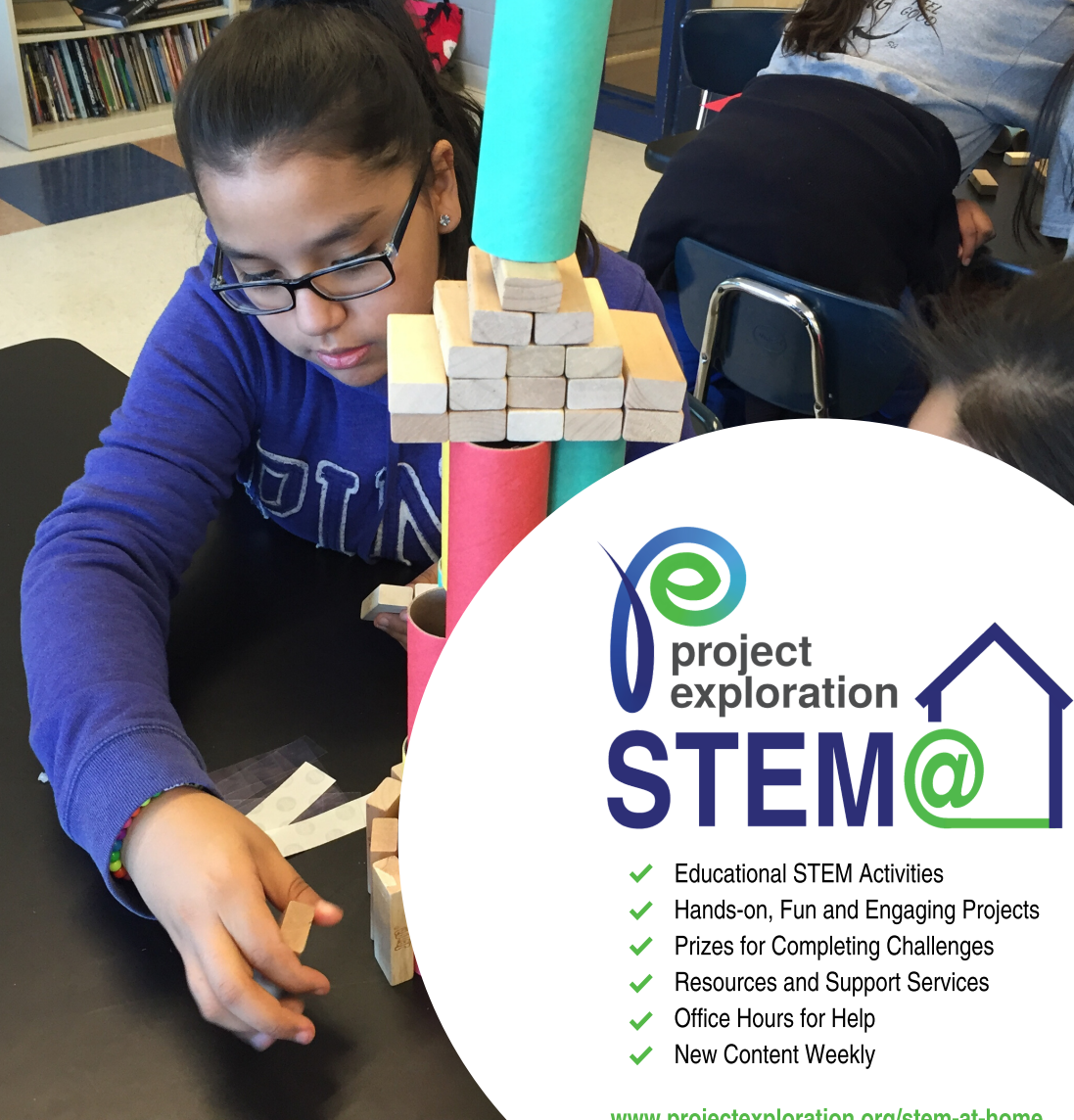

The young people PE serves have always been at greatest risk of falling behind.

While learning loss can be expected among all students regardless of background during Covid-19 school closures, studies show that community wealth can provide the needed support for students who have missed too much school (The Atlantic, 2016). For Students

For Parents
