Explain :

CDM Smith is able to certify all except b. There has only been one judgement. In April 2017, the City of Santa Barbara filed a lawsuit against CDM Smith Inc. alleging negligence and breach of contract in the performance of a water treatment plant improvements project. CDM Smith

Inc. was found negligent, and the matter was resolved in November 2019. Following the court's instruction, the jury apportioned 40% of the liability to CDM Smith. In an unusual turn of event, the judge reversed himself and rejected the jury's apportionment of liability among three parties and ordered CDM Smith to pay the entire amount of damages found by the jury. It was decided that resolving the matter promptly through a negotiated settlement rather than pursuing a lengthy and costly appeal was the most cost effective solution. We emphasize that this did not have a material impact on the business and there are no outstanding obligations owed by CDM Smith.

Additional Ownership Information:

CDM Smith Inc. has established the CDM Smith Inc. Capital Accumulation Plan for the benefit of its employees in accordance with the requirements of the Employee Retirement Income Security Act of 1974. The same federal identification number is used. ("CDM Smith CAP Plan") Employees, at their election, may participate in the CDM Smith CAP Plan and contribute a portion of their salary/wages on a pretax basis into the CDM Smith CAP Plan. The money contributed by the employees may be invested into several funds that are managed by an outside firm called Vanguard.

As part of the CDM Smith CAP Plan, the Company has also established a 401K Trust to hold Company stock for the benefit of the 3,235 employees who participate in the CDM Smith Capital Accumulation Plan. Each year, based upon the Company's performance, the Company may match (up to a certain percentage) an employee's contribution into the CDM Smith CAP Plan through the contribution of Company Stock into the Trust. Employee who are beneficiaries of the CDM Smith 401K Trust do not have any voting rights to the CDM Smith stock held in the CDM Smith 401K Trust. The five (5) trustees of the CDM Smith 401K Trust vote the shares of the CDM Smith Stock held on the CDM Smith 401K Trust.

Currently, the CDM Smith Capital Accumulation Plan owns approximately 45% of CDM Smith Inc.
