Acacium Group Holdings Ltd is controlled through an investment fund structure by Onex Corporation, a Canadian headquartered investment firm, which is the group's ultimate parent undertaking, registered at 161 Bay Street Toronto, ON M5J 2S1 Canada. Onex Corporation have a 79% stake in Acacium Group. Gerald W. Schwartz, a Canadian citizen and chairman of Onex, controls Onex Corporation by holding indirectly all the outstanding Multiple Voting Shares of Onex. The holders of Multiple Voting Shares are entitled, voting separately as a class, to elect 60 per cent (rounded to the nearest whole number) of the members of the board of directors of Onex. Mr. Schwartz also holds directly or indirectly, 13% of the outstanding Subordinate Voting Shares of Onex Corporation for his economic ownership.

TowerBrook Capital Partners, a New York based hedge fund co-controlled 50:50 by Neal Moszkowski and Ramez Sousou, own ~19.9% of the Group through Indigo Cayman 2 Ltd.
