The young people PE serves have always been at greatest risk of falling behind. As an "anchor organization," we convene community-level stakeholders and caring adults committed to youth development, such as youth workers, faith leaders, school staff. etc., to mobilize strategies to connect young people of all ages to engaging and meaningful out-ofschool time programming in the **Austin Community.**



In collaboration with community stakeholders, we have developed the **Austin Community Plan to outline** our strategy for connecting youth to local out-of-school time programming. This plan aims to address and overcome challenges that limit youth access to these programs. A key component of our approach involved conducting a community needs assessment to evaluate the strengths and resources available to support children, youth, and families, as well as to identify existing gaps. The insights from this assessment will help our partners better understand regional barriers and uncover opportunities for improvement and growth.

Austin Community Needs Assessment

A UNIQUE APPROACH

Over the past year, we have advanced Project SYSTEMIC 2.0, a systems-thinking framework that builds on the foundational work of the original Project SYSTEMIC initiative, which applied a systemic approach to developing a STEM ecosystem in Chicago's Austin neighborhood. Initially designed to broaden STEM participation among African American and low-income Chicago Public School students, Project SYSTEMIC focused on uncovering systemic interdependencies contributing to youth access and participation barriers.

The original initiative engaged a wide cross-section of community stakeholders, using innovative, interactive problem-structuring and solving strategies to map the STEM ecosystem and develop evidence-based organizing and implementation strategies. This community-driven approach aimed to elevate historically excluded neighborhood voices, build local capacity, and enhance coordination and resource sharing among partners to address STEM access challenges.

Building on this legacy, Project SYSTEMIC 2.0 extends these principles to address out-of-school time (OST) programming barriers in Austin, one of Chicago's most underserved neighborhoods. To support this effort, we designed and implemented a survey capturing student interests across Austin community schools, Network 3, and Network 15, providing an empirical foundation for strategy development. This iterative and collaborative approach continues to leverage systems thinking and culturally responsive methodologies to foster sustainable, community-centered solutions for youth development and access.

OVERVIEW


Since 2019, our initiative has assessed student interests and community factors like safety, transportation, and program availability, identifying key assets and barriers to out-of-school time (OST) participation. In 2021, we partnered with MAPSCorp to map Austin's assets, uncovering insights into youth activities, OST spaces, and accessibility. To address systemic barriers, we launched Project SYSTEMIC 2.0 in 2024, using a systems-thinking approach to gather qualitative data and improve OST programming.

OUR FINDINGS

Nine targeted focus groups conducted with key stakeholders, including youth, students, community-based organizations, Chicago Public Schools (CPS) administrators, Chicago Park District representatives, parents, businesses, and public safety officials, informed the findings from Project SYSTEMIC 2.0. These diverse perspectives comprehensively understood the barriers impeding access to out-of-school time (OST) programming in Austin. The following are key barriers identified:



These findings highlight the interconnected nature of the barriers and the importance of employing a systems-thinking approach to address them effectively. Key recommendations include strengthening communication strategies to increase awareness of available programs, building partnerships to enhance transportation options, designing youth-centered programs that align with their interests, actively engaging parents to foster support and involvement, and implementing robust safety measures to ensure secure and reliable access to OST opportunities. These insights will inform the development of targeted, actionable strategies to promote equitable access and meaningful engagement in OST programming for Austin's youth.

TRANSPORTATION

 A lack of reliable and affordable transportation emerged as a critical barrier, preventing many youth from accessing OST programs. This challenge was particularly pronounced for families without personal vehicles or those who rely on public transit, which may be limited or unsafe during specific hours.

PROGRAM AWARENESS

 Many stakeholders noted that families and students are often unaware of the OST opportunities available in their community. The lack of centralized communication or effective outreach contributes to low participation rates and underutilizing existing programs.

PARENT INVOLVEMENT

 Parental engagement was a significant factor in encouraging youth participation in OST programs. Barriers such as work schedules, lack of trust in program providers, or limited awareness of the value of OST activities hinder parental involvement.

SAFETY CONCERNS

 Both real and perceived safety concerns were frequently mentioned, particularly regarding travel to and from program locations. Violence, crime, and unsafe transit routes deter youth and their families from participating in OST activities, especially during evening hours.

YOUTH APATHY

 Apathy or lack of motivation among some youth was highlighted as a barrier, stemming from limited exposure to programs that align with their interests or aspirations. This disinterest may also reflect broader systemic challenges, such as low expectations or a lack of role models demonstrating the value of participation.





STRATEGIES TO CONSIDER TO ADDRESS BARRIERS TO OUT-OF SCHOOL TIME PARTICIPATION

Transportation

- Partner with local transportation services, community organizations, and schools to provide subsidized or free shuttle services for youth attending OST programs.
- Explore partnerships with ride-share companies for discounted youth transportation.
- Implement neighborhood-based programming to reduce the distance youth need to travel.

Program Awareness

- Develop a centralized platform or resource hub, such as a community website or mobile app, to list all available OST programs and activities.
- Launch targeted marketing campaigns to reach parents and youth using social media, local radio, and school communications.
- Host community events to showcase OST opportunities and engage families directly.

Parent Involvement

- To accommodate diverse schedules, offer flexible engagement opportunities, such as virtual information sessions or evening/weekend events.
- Build trust with parents through consistent communication and testimonials from other families.
- Highlight the long-term benefits of OST participation for youth development and academic success to encourage buy-in.

Safety Concerns

- Partner with the 15th and 25th Police Districts and community safety organizations to ensure safe transit routes to and from OST programs.
- Offer programs within walking distance in safe locations, such as schools, churches, or community centers.
- Implement buddy systems or group travel arrangements to enhance security and parental confidence.

Youth Apathy

- Conduct surveys and focus groups to identify youth interests and design programs that reflect their passions and aspirations.
- Incorporate mentorship and role models into programming to inspire and motivate youth.
- Include experiential, hands-on learning opportunities that demonstrate the realworld application of skills gained in OST programs.

Addressing these barriers through collaborative and targeted strategies aims to foster greater access and engagement in OST programming, ensuring all Austin youth have equitable opportunities to learn, grow, and thrive.

PROGRESS OF OUR PROJECT

CONCLUSION & NEXT STEPS

Project SYSTEMIC 2.0 represents a transformative effort to address systemic barriers to out-of-school time (OST) programming in Austin, one of Chicago's most underserved neighborhoods. Building on the foundational work of the original Project SYSTEMIC initiative, this project leverages a systems-thinking framework to develop sustainable solutions that elevate youth access to high-quality programming.

Through extensive community engagement, including nine targeted focus groups with diverse stakeholders, the project identified five critical barriers: transportation, program awareness, parent involvement, safety concerns, and youth apathy. These findings underscore the interconnected nature of these challenges and the importance of a coordinated, data-driven approach to overcome them.

Key Achievements

- Comprehensive Stakeholder Engagement: Successfully brought together youth, families, schools, community organizations, businesses, and public safety officials to inform the work.
- **Empirical Data Collection**: Conducted surveys to capture student interests and assess community resources, laying a strong foundation for targeted interventions.
- Strategic Framework Development: Crafted actionable strategies to address each barrier, including partnerships to improve transportation, centralized communication platforms, and youth-centered program design.

Next Steps

1. Implementation of Strategies

- o To address mobility challenges, pilot transportation solutions, such as subsidized shuttles.
- Launch a centralized program information and awareness platform supported by targeted marketing campaigns.

2. Strengthening Community Partnerships

- Continue to work with Austin providers to build capacity and align resources toward shared goals.
- Engage parents through workshops and outreach initiatives that build trust and highlight the benefits of OST programs.

3. Safety Enhancements

- Partner with the 15th District and community groups to ensure safe travel pathways.
- Expand programming to locations within safe walking distances for youth and families.

4. Youth-Centered Program Development

- Use survey insights to design programs that align with youth interests, integrating mentorship and hands-on experiences to foster engagement.
- Continuously seek youth input to refine and adapt programming.

5. Monitoring and Evaluation

- Establish metrics to track participation, engagement, and the impact of implemented strategies.
- Use systems-thinking and culturally responsive evaluation methods to adapt and scale successful interventions.

This work sets the stage for creating a more equitable OST ecosystem in Austin, empowering youth with opportunities to thrive academically, socially, and personally. By addressing systemic barriers collaboratively and innovatively, Project SYSTEMIC 2.0 aims to transform the Austin community into a model for inclusive and effective youth development initiatives.
