NTT DATA has disclosed all persons or entities with a direct or indirect beneficial ownership interest in excess of 7.5% of NTT DATA Americas, Inc. as the Applicant. The Master Trust Bank of Japan Ltd. holds 11.63% of the shares of NTT DATA Group Corporation in a trust account where the Bank is a trustee for the benefit of its customers. Further Custody Bank of Japan, Ltd holds 6.16% of the shares of NTT DATA Group Corporation in a trust account where the Bank is a trustee for the benefit of its customers. Japanese authorities do not regard banks holding shares in a trust account as an actual shareholder. Under Japanese law, NTT DATA Group Corporation is required to disclose to the Japan Ministry of Finance any shareholder owning more than 5% of the company's shares in a large shareholders' report. NTT DATA Group Corporation does not file information for The Master Trust Bank of Japan, as it is a trustee for the benefit of its customers, nor did NTT DATA Group Corporation file information for any other shareholder.
