Explain:

EDI is able to certify to A, B, C, and E listed above, but unable to certify to D, as explained here: Throughout the duration of EDI's 20 years in providing professional services, only one client terminated a contract with EDI in 2007. EDI contested the contract termination with the Chicago Public Schools and was denied the right of appeal. EDI disputes the reason for contract termination and denies any failure to perform professional services in accordance with the contract provisions. EDI has not incurred any claims for failure to comply with contract requirements during our 20-year history. EDI continues to provide professional services to the Chicago Public Schools under separate contracts, including currently providing Environmental Design Management services for the Chicago Public Schools, Capital Improvement Program.

3.
