Explain:

M.A.T. Leasing has received City of Chicago Municipal tickets in the last 5 years, at 750 N. Kilbourn, a city owned facility. M.A.T. has resolved all such ticketed violations by either contesting them resulting in dismissal, or contesting them and arriving at a settlement that was both acceptable to the City and M.A.T. without proceeding to a hearing. The fines that were paid did not exceed \$500.00 in any one instance and corrective measures were taken to avoid further violations, 3 of the tickets involved debris associated with the operation of a City owned transfer station, and basically involved loose debris overflowing from City owned trucks dumping at the site. Three other tickets were issued involving paving and surfacing roadways at the same facility. M.A.T. has not received any such violations at either the State or Federal level. M.A.T. does not feel that it has violated environmental laws of the type contemplated in the RFQ or the associated certifications.

3.
