Under the Retained Parties tag - question #3, we were unsure if this was a duplicate of the previous question, but as the fields provided only allowed for individual information (not business) it was perceived to be in reference to individual lobbyist, etc and not businesses retained in reference to this contract and was marked NO. In addition, we referenced Stevenson Crane Services twice - once as a primary supplier/subcontractor with the estimated amount of their area of the contract, and again as a certified WBE subcontractor with that estimated amount. The reason is the dollars estimated as a WBE subcontractor will be applied as indirect participation. We are unsure if this is the proper way to differentiate between the two elements, but wanted to identify both roles that Stevenson would play in this contract. EDS was returned due to wrong vendor number - vendor number from returned email - #736527
