South Central Community Services, Inc. is a 501c3 not for profit comprehensive social service agency that has served the Chastham/Avalon on the south side of Chicago for over 40 plus years. During the past several years, as well as many other community organizations, we have been receiving delinquent payments fro the State of Illinois with whom we receive ove 95% if iur revenue. In order to pay staff we were unable to fully make tax payments starting in the 2nd quarter of fiscal year 2011. It was our intent to settle the amount due during the period Jan. 1, 2012 to March 31, 2012. Acording to our funders this was the period in which back payments due were to be released and current payments due were to be timely. Paychex Payroll Co. is the processor of agency payrolls. Paychex in the past filed the quarterly tax returns on behalf of the agency. Paychex without the agency?s knowledge did not file reports after June 30, 2011. We learned of this matter when I and the Treasurer of
