NTT DATA provides the following information regarding pending tax matters with the State of Illinois in support of NTT DATA's certification under Section VII, Question F.1 in Economic Disclosure Statement #37931:

NTT DATA, Inc. (f/k/a Keane, Inc.) was included in the Illinois unitary income tax return filed by its parent, NTT DATA International Services, Inc. (f/k/a/ Keane International, Inc. f/k/a/ Caritor, Inc.), for the year ended December 31, 2009 on which NTT DATA International Services, Inc. claimed a net operating loss carryforward. The State of Illinois disallowed the loss carryforward, since Caritor, Inc. did not file Illinois Income Tax Returns for 2002 and 2003. As a result of the State's disallowance of the loss carryforward, the State issued an assessment against NTT DATA International Services, Inc. for 2009 in the amount of \$18,998 for tax and penalty. Caritor's returns for 2002 and 2003 were filed on November 15, 2012 showing that no income tax was or is owed by Caritor to the State of Illinois for 2002 and 2003. With the missing returns now filed, NTT DATA anticipates that the State will allow the loss carryforward on NTT DATA International Services, Inc.'s 2009 return, and no tax will be due. On February 28, 2013, Beverly Sinkiewicz, Tax Manager for NTT DATA, spoke with George in the Illinois Department of Revenue, who confirmed that the 2002 and 2003 returns for Caritor had been received and that there was no further action required of NTT DATA regarding the matter while the returns are under review.

Separately, NTT Data International L.L.C. (parent of NTT DATA International Services, Inc.) filed a State of Illinois Income Tax Return for the year ended December 31, 2011. The Illinois Department of Revenue questioned tax payments reported on the return and issued a Final Notice of Tax Due on December 18, 2012 showing a \$20,101 balance due. The matter subsequently went to Illinois DOR Collections. On January 18, 2013 NTT DATA submitted documentation in support of the tax payments reported on the aforementioned return. On February 19, 2013 Ms. Sinkiewicz left a message on the Illinois Department of Revenue voice mail system asking if the documentation had been received. On February 25, 2013 a representative from the Illinois Department of Revenue left a voicemail message for Ms. Sinkiewicz confirming receipt and indicating that a stop had been placed on all collections activity relating to the

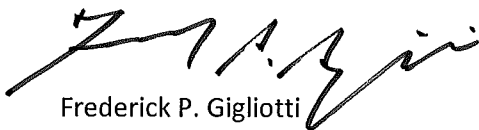
matter as of February 1, 2013, while the Illinois Department of Revenue's review of NTT DATA's material is pending. On March 5, 2013, Ms. Sinkiewicz again called the Illinois Department of Revenue and spoke with Roger, who confirmed that the matter is no longer in collections and is now being processed by the State.

On another matter, Intelligroup, Inc. (previously an affiliate of NTT DATA, Inc. based in New Jersey that was merged into NTT DATA, Inc. as of March 31, 2012) filed a timely Illinois Income Tax return for the year ended December 31, 2009 showing a net operating loss carryforward. The Illinois Department of Revenue disallowed the loss carryforward, however, since Intelligroup's 2007 Illinois return had not been filed. The Illinois DOR then issued a Notice of Tax Due in the amount of \$6,997. The matter subsequently went to Illinois DOR Collections. On January 18, 2013 a copy of Intelligroup's 2007 return was faxed to Daniel Bartolazzi at the Illinois Department of Revenue. On January 29, 2013 Ms. Sinkiewicz spoke with Mr. Bartolazzi, who informed her that he had received the missing return, and a Stop Bill on collections activity relating to the matter was placed on Intelligroup's 2009 return pending his review of the information.

On a final matter, Intelligroup filed its Federal Income Tax Return for the year ended December 31, 2010. The Federal return was filed within the time permitted by the Internal Revenue Service for taxpayers affected by Hurricane Irene. The State of Illinois, however, did not grant Hurricane Irene relief, so Intelligroup filed a timely State of Illinois Income Tax Return using the best information it had available at the time. After Intelligroup filed its 2010 Federal return, it also filed an amended 2010 Illinois return. On September 6, 2012 the Illinois Department of Revenue requested a copy of Intelligroup's amended Federal return. On October 30, 2012 the Illinois Department of Revenue issued a Final Notice of Tax Due showing a balance due of \$116.00, since there had been no response to its request. The matter then went to Illinois DOR Collections. On January 17, 2013 Intelligroup issued a letter to the Illinois Department of Revenue explaining its 2010 tax filing and the rationale for why an amended Federal Income Tax return is not required. Mr. Bartolazzi told Ms. Sinkiewicz in their January 29, 2013 conversation that a Stop Bill on collections activity also was placed on Intelligroup's 2010 return pending his review of the information.

As a result of NTT DATA's filings and the Illinois Department of Revenue's issuance of stops on all collections activity relating the above-described tax matters, NTT DATA is able to certify that it is not now delinquent in the payment of taxes administered by the Illinois Department of Revenue. Additionally, as required by Economic Disclosure Statement Section VII, Question F.1, NTT DATA affirms its certification that no fine, fee, tax, or other charge is owed to the City of Chicago as of the date of this letter.
