MAT certifies 2.a-d to be true and the following is the explanation for 2.e.MAT has received City of Chicago tickets in the last 5 years, at 750 N. Kilboorn, a city owned facility. MAT has resolved all such ticketed violations by either contesting them resulting in dismissal, or contesting them and arriving at a settlement both acceptable to the City and MAT without proceeding to a hearing. The fines have been minimal and corrective measures were taken to avoid further violations. MAT has not received any such violations at either the State or Federal level. MAT does not feel that it has violated evvironmental laws of the type contemplated in the contract or the associated certifications.

- 3.
