Explain :

On March 16, 2010, the City of Chicago sent a Notice of Proposed Debarment to the Disclosing Party and all the persons identified in Section II.B.1 of the EDS, to which their attorneys have

responded, contesting the Notice. On March 27, 2012, the Chief Administrative Law Judge of the City's Department of Administration appointed a hearing officer to schedule and conduct a hearing on the proposed debarment. There have been two days of evidentiary hearings but the evidentiary hearings have not concluded. Neither the Disclosing Party nor those persons "are presently debarred, suspended...declared ineligible or voluntarily excluded from any transactions by any federal, state or local unit of government." There are no entities identified in Section II.B.1 of the EDS.

3. Neither the Disclosing Party, nor any [Contractor](#), nor any [Affiliated Entity](#) of either the Disclosing Party or any [Contractor](#) nor any [Agents](#) have, during the five years before the date this EDS is signed, or, with respect to a [Contractor](#), an [Affiliated Entity](#), or an [Affiliated Entity](#) of a [Contractor](#) during the five years before the date of such [Contractor's](#) or [Affiliated Entity's](#) contract or engagement in connection with the Matter:
