Infor is a multinational group of companies with thousands (if not hundreds of thousands) of agreements in place. As with any large commercial enterprise, over the course of Infor's lengthy history there have been contract disputes. Where such disputes arise, Infor's standard procedure is to achieve an amicable resolution by directing its efforts to resolving disputes through communication and dialogue. It should be noted, however, that there is currently no pending or prior dispute, claim or action that would be likely to materially and adversely impact the work proposed to be performed for the City of Chicago or Infor's ability to provide the requested products and services.

3.
