
ORDER

Re: SOUTH CENTRAL COMMUNITY SERVICES


The Board of Appeals hereby compromises all remaining balances due on the Petitioner's WIT liabilities for the 4th Q of 2011 and the 1st, 2nd & 3rd Qs of 2012 for \$114,000.00, payable first with a down payment of \$6,500.00 due within 60 days of the date of this Order & then with the remaining balance of \$107,500.00 payable in equal installments of \$1,800.00 per month for 60 months or until said \$107,500.00 plus the appropriate statutory accrued interest thereon are paid in full. The Petitioner shall make its first installment payment within 30 days of the down payment & all subsequent installments every 30 days thereafter. Interest accrues on all unpaid balances until the debt (as compromised herein) is paid in full, provided that the Department shall apply all payments received on or after 10/10/13 to the compromised amount. The Board grants this compromise subject to the express condition that the Petitioner must file, and make any necessary payments on, its WIT return for the 4th Q of 2012 within 30 days of the date of this Order. If the Petitioner fails to abide by this condition, or defaults on any of its other legal obligations to IDOR, then this Order may be vacated, whereupon the Petitioner may immediately forfeit all relief granted herein.


