Attachment to Economic Disclosure Statement and Affidavit

In March 2010, the City of Chicago sent a Notice of Proposed Debarment to the Disclosing Party and both persons identified in Section II.B.1. The Chief Administrative Law Judge of the City's Department of Administrative Hearings appointed a hearing officer to conduct a hearing and subsequently, the parties entered into a Settlement Agreement (the "Agreement"). Under the Agreement, the City agrees to withdraw and terminate the Notice of Proposed Debarment and its Request for a Hearing; and City Utility agrees that for two years, it will not seek, bid on, accept, or perform any New Business from the City or its sister agencies, including any contract that is not identified in Exhibit A to the Agreement, which lists City Utility's current contracts and subcontracts that continue in full force and effect. One of those contracts is Contract Number 24025. Further, each of the persons identified in Section II.B.1 has agreed that for two years, he will not become employed by, acquire an ownership interest in, or associate himself with an entity that is seeking, bidding on, accepting, or performing any New Business.

Other than above, we are able to certify.
