I am able to certify the above to be true. This being said, in an effort to provide complete transparency, I did want to add that Parsons Brinckerhoff* was purchased in October 2014. WSP Global Inc., a Canadian owned professional services firm, is now the ultimate parent of Parsons Brinckerhoff*. WSP Global Inc., a public entity, and its affiliates have never been charged by a public body or convicted for issues related to inappropriate bidding practices or unethical behavior associated to acts described in paragraph b. However, a local commission of inquiry into the awarding and management of construction contracts in the province of Quebec, colloquially called the Charbonneau Commission, began hearings in 2012.

Over a span of two years, most consulting engineering firms were in some way asked by way of active and ex-employees, to testify on potential inappropriate bidding practices or unethical behavior which may have taken place in the industry, several years back. The matter is still under investigation by authorities including the Canadian Competition Bureau. GENIVAR, now WSP Canada Inc., a direct subsidiary of WSP Global Inc., had ex-employees who allegedly participated in improper acts. The most recent update on the Charbonneau Commission as it pertains to WSP Global Inc. can be found in annual reports.
