(ATS) received a notice from the City of Sarasota, Florida, notifying ATS that it has terminated its contract with ATS for the design of a sewer lift station for default. ATS disagrees with the termination and is contesting it; (2) In March of 2016, AECOM Technical Services, Inc., received a Notice of Termination for Cause from Atlantic City Electric, a PHI Company, on a Substation Project. AECOM disagrees with the purported basis for the notice and is contesting this notice.
