B. Further Certifications Subsection 6-Explanation

While the Disclosing party feels it can certify to “Further Certification B(1)(e)” as to not having had any convictions, guilt or liability for any environmental violations, as set forth in the bid packet, Sections 2.44 and 2.52, the Disclosing Party is providing the following information in the interest of full and complete disclosure.

In 2006 Michael A. Tadin, a Disclosing Party had a default Judgment entered against him by the City of Chicago Administrative Hearings Department (Exhibit A). The default occurred as a result of improper notice by the City for two municipal tickets which were the subject matter of the Administrative hearing but were never provided to Michael Tadin. He subsequently obtained copies from the City or the tenant (See ticket copy attached as Exhibit B, it should be noted that only one ticket was provided by the City Hearing Department) The address on the tickets and the hearing order were at an address that Michael A. Tadin had not resided at since 1998 (3346 S. Emerald, Chicago, IL). That is why he received no notice of the proceeding. A default judgment was entered and subsequently the matter was turned over for collection by the City. It was at the time a wage assignment order was entered by the collection firm for the City that Michael A. Tadin first became aware of the City’s judgment. On the advice of counsel Michael A. Tadin paid the outstanding amounts due for the tickets under the default judgment.

The facts pertaining to the issuance of the tickets are in dispute. Michael A. Tadin owns a property at 4335 S. Western Blvd. in Chicago, Illinois. Title for the property was held in a land trust. The property was leased to Kinsella Landscaping. Apparently two tickets were issued for violations. The only ticket copy available (Exhibit B) has a violation date of 1-18-2006. The City report (Exhibit C) has an inspection date of 1-27-06, and states Notices of Violations were mailed to the tenant, Kinsella Landscaping. On February 22, 2006, another City report (see Exhibit D) details that the site had been cleaned up and shows the complaint as closed. That was the understanding of Michael A. Tadin, that the matter had been resolved. Had it not been resolved, Michael A. Tadin would have disputed the tickets. The City report of 2-27-06 (Exhibit D) reflects the correct address for Michael A. Tadin as 4450 S. Morgan. The City therefore had notice of the correct address for Michael A. Tadin. Notwithstanding that knowledge, the City continued to utilize the Emerald street address, for the Hearing (see Exhibit E as to notice at last known address) and subsequent notices as apparently all correspondence and service were at the Emerald address. Had service been proper Michael A. Tadin could have and would have disputed the violation notices. Once the default judgment was entered no further notice occurred until the wage assignment issued (see Exhibit F) nearly 6 months after the default and more than 7 months after Michael A. Tadin thought the matter had been resolved. Rather than fight the

matter on advice of counsel, based on the relative costs and benefits, Michael A. Tadin paid the judgment.

The Disclosing Party does not feel that he violated any environmental laws as set forth in Sections 2.44 and 2.52 of the RFQ, given that the tickets cited Municipal code sections 7-28-080 and 7-28-450. Further there is the issue of being found liable. The matter was a default based on improper notice despite the City's own records reflecting a correct last known address for Michael A. Tadin at 4450 S. Morgan and NOT at 3346 S. Emerald. In the interest of full disclosure the foregoing information is provided as an explanation as part of the Certifications, notwithstanding that it is the position of the Disclosing Party that he has not violated any environmental laws.
