With regards to item (d), pertinent to termination for default of public transactions, we have this answer: (1) in November of 2012, AECOM Technical Services, Inc. (ATS) received a notice from the City of Sarasota, Florida, notifying ATS that it has terminated its contract with ATS for the design of a sewer lift station for default. ATS disagrees with the termination and is contesting it. (2) In August 2016, ATS received a letter from the Redevelopment Authority for the City of Milwaukee asserting that the Authority considered its contract with ATS terminated for cause. ATS believes the termination is unjustified and ignores relevant Project history. ATS is contesting the termination, and will actively work with the client to address the client's underlying concerns.
